5. **Relevance of Practical Components:** Improvements will be made to enhance the alignment between practical components and real-life applications, considering the feedback provided by participants (31.53%) who rated it below 4. This may involve revising and updating practical components to ensure their direct relevance and applicability to real-world scenarios.
6. **Overall Contribution to Student Development:** Efforts will be made to address the concerns of participants who rated the overall contribution of the syllabus to student development below 4. This may involve refining and expanding the syllabus to cover a wider range of skills, knowledge, and competencies, thereby enhancing its impact on student development.
7. **Development of Learning Values:** The concerns of participants (27.83%) who rated the development of learning values below 4 will be addressed. Strategies will be implemented to further foster the development of learning values, such as critical thinking, problem-solving, collaboration, and ethical decision-making.

Action Taken Report on Alumni Feedback [AY 2021-22]

This comprehensive report aims to analyze and address the alumni feedback on the quality and relevance of the curriculum at an unspecified university (AY 2021-22). The data presented in this report is based on the responses received from alumni through a feedback questionnaire. The questionnaire utilized a rating scale from 1 to 5, with 1 being the lowest rating and 5 being the highest. The responses were collected from alumni. The purpose of this report is to present a thorough analysis of the feedback and outline the action taken to enhance the curriculum.

Summary of Findings: The alumni feedback indicates an overall positive sentiment towards the curriculum, with varying levels of satisfaction across different parameters. Notable findings from the alumni responses include:

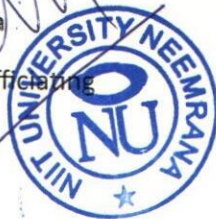

6. Strengthening Societal and Environmental Initiatives:

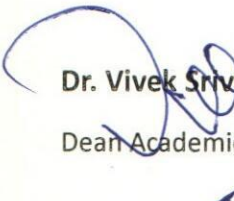
